A legacy is a memorialization, an investment in the future. It allows remembrance. A charitable bequest is the simplest form of legacy gifting. In a will, particular assets, a fixed dollar amount, or even a percentage or the remainder of an estate can be given to Hope Service Dogs, Inc, 501 (c)(3) Non-Profit.

Your legacy will help individuals with disabilities access a service dog required to improve their life. It will allow HSD to continue the Warrior Program, pairing service dogs with veterans, and the Hope for the Future Scholarship for training service dogs.

#### Charitable Bequests

A charitable bequest is simply a distribution from the estate to a charitable organization through the last will and testament. There are different kinds of bequests. Specific language to indicate the precise direction of your final wishes. In a charitable bequest, name the recipient accurately and include the organization's address and federal tax identification number. This information is available in HSD's "Declaration of Intent".

#### Do you have an estate?

An estate is the sum of all assets, including property, insurance policies, retirement accounts, cash on hand, etc. Wealthy people may have very large estates, but many Americans have the resources to make a charitable bequest. If every adult in America bequests \$100 to charity, billions of dollars would support causes annually.

#### Bequests

Carefully review the terms with a professional trained in handling trusts and estates.

General Bequests designate a specific dollar amount, particular asset or fixed percentage to the chosen cause. Specific Bequests are made when a particular item or property is bequeathed for a designated purpose. Residuary Bequests are a portion of assets after other terms of the will have been satisfied. Contingency Bequests provide to a particular charity if your named beneficiary does not survive you.

#### Why a Will is Needed

Without a will, there is no guarantee that your final wishes will be met. Some steps you should take to make sure your wishes are granted include the following:

- Set an appointment with a financial analyst/attorney, set up an appointment with/notify HSD of your intention to designate/support. The accountant or attorney will guide you through the process.
- a list of organizations or causes that you would like to support.
- a detailed list of your assets (financial, real estate, vehicles, jewelry, collectibles, etc.)
